**ABOUT THE FACILITY**

**Arenas & Footing**

Tests will be ridden outdoors in sand arena unless weather is very inclement.

Out door arena is 20mx60m. Indoor warm up arena is tri-rubber and sand .

If competition is moved indoors all tests will be ridden in 20m x 40m arena.

Inroductory level tests may be ridden in a 20m x 40m, (judges discretion)

either indoors or outdoors.

**Stabling**

12 x 12 box stalls with bagged pelleted bedding provided. Extra bedding available with additional charge.

**Awards**

Awards to first place, ribbons first place – 6<sup>th</sup>. High percentage award for each level,
