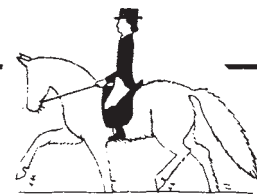

Arenas & Footing

Indoor competition arena, dirt improved with sand and sawdust. Covered warm-up arena, dirt footing. Intro - Training level and Quadrille tests ridden in short arena; all other tests ridden in standard arena.
